12. CONSIDERATION OF MOTIONS RECEIVED

 A letter was received from Mr Andries van Niekerk but was submitted too late for inclusion under this section. The matter will be brought up for discussion under General

13. GENERAL MATTERS

- The Chairperson read out the letter received from Mr Andries van Niekerk requesting scrapping the prize for the best gross at monthly mug & medal events
 - Motivation is that players with an 8 or higher handicap will not have much chance to ever win
 - Proposal is to either scrap the prize or add in an additional prize
 - Danie went through the breakdown of income/costs for medal events. Prize for best gross is R300
 - On mug events, the prizes are a bit higher as costs are lower. Mug gross winner gets R700
 - Danie agrees with Andries that YTD winners are almost always lowhandicapped players
 - However, lower handicapped players hardly ever qualify for IPS prizes. That is the reason the prizes for "best gross" were introduced
 - It is important that lower handicapped players also participate in the competitions and that there is incentive for them to participate

Geoff Miles

- Asked about cart trail levy sole purpose was for the club to lay down concrete paths. Paths were laid down 10 years ago why are members still paying the cart levy (which has increased exponentially over the last few years)
- o Requested a written response from the Golf Committee to all members

Johan Struwig

- Mentioned that there is little control on where members drive carts they are not always using the designated cart paths
- Danie responded that they will look into ways of monitoring this better



Geoff Miles

- Feels that security at the club is not up to scratch cars still being stolen & golf cart chargers have been stolen
- Suggested boom with spikes
- Also concerned with lack of security cameras

Alan Eagan

- Enquired about survey sent out regarding upgrades to club
- Danie responded that this is a Governing Body matter and will be handled in the Club AGM
- Also enquired about sponsorship request

Geoff Milles

- Asked how many Full Members there are and why the early payment discount was removed for Men's Full Membership - Danie responded that they will investigate
- Also asked about PlayMoreGolf and the status of that. Danie mentioned that
 the rounds decreased after the increase in green fees from PMG, but there
 were many members who were upset that the PMG members had such a
 low green fee rate and were using up all the parking
- Danie also mentioned that the Under 35 membership category was a great idea and many PMG members converted to Under 35 membership
- Geoff is concerned that if we lose PMG the Club will not be financially sustainable
- Danie said that we already have a problem that new members already struggle to get a slot on a Saturday
- Johan Struwig mentioned that there is no real danger from PMG the bigger threat is Last Minute Golf. He also asked the Golf Committee to look at Thursdays when there is a competition on - affiliated players only pay a small amount more than members
- Danie said that Golf Committee will investigate all these matters and refer back to members
