### CLASSES OF MEMBERSHIP

# 3.1 Classes of Membership

Membership shall consist of Club Members and Associate Members. Club Members shall consist of, **Affilliated** Golfers, Honorary, Honorary Life and Pensioner classes. **Associate** Members shall consist of Individual, Family, Pensioner, Individual Country, Family Country, Student/Scholar, Reciprocity and Temporary classes.

# 3.1.1 Club Member

Any person who is an affiliated golf member.

# 3.1.2 <u>Member / Individual shall be</u>:

Any person who falls under Associate member class as defined in the Rules

## 3.1.3 Family Member shall be :

A family unit and whose children are not self-supporting. Family membership will cover those members of a family who have completed their schooling and who are attending a tertiary education institution full time.

## 3.1.4 Individual or Family Country Member shall be :

Those not desirous of becoming Full Members and who neither ordinarily reside or carry on a business or are ordinarily employed within the uMshwathi Local Municipality.

# 3.1.5 Student Member shall be :

People who are under the age of 18 years, or <u>bone fide full</u> time students attending a tertiary education institution, who have applied for and are granted Membership. People under 18 years require the consent of his/her parent or guardian. Any amounts owing by Student members, under the age of 18 years, shall be the responsibility of the parent or guardian. Student Members shall not have the right to vote at any meeting of the Club nor the privilege of introducing guests to the Club and shall be entitled to enjoy only such privileges as the Club Committee may deem fit and on the understanding that such privileges shall at all times be subservient to those of other classes of members. On attaining the age of 18 years, Student Membership shall automatically cease for people not attending a tertiary education institution and he/she may thereupon make application for admission as another class of member.

# 3.1.6 Pension Member :

A Pensioner Member is a person whose income is derived from a pension or retirement fund and who is no longer permanently employed.
