The second wave of Covid-19 infections has had a severe impact on our January results.

In January we reported that al the indicators tracked within or better than budget as at the end of December, but January has thrown all into negatives given a net loss of R22k for the month (versus the budget set at a profit of R667k for this summer month).

Despite restrictions being eased, we forecast that revenues will be more than R1m behind budget in February. It is clear that the uncertainty in the market following the second wave will impact us over the longer term. Therefor there continues to be a strong focus on cost saving and how we prioritize capital expenditure.

While our cash reserves are at a healthy level, to maintain a liquidity ratio (current assets/current liabilities) of 2:1 or better, cash reserves of R9.2m to R11.5m will provide for a fair risk mitigation.

These balances are determined taking into consideration the financial position at our two most recent year ends (July 2020 and July 2019). These amounts are also closely aligned to the principle of keeping reserves at a balance to fund six months of operating expenses.

While our Capex/Project budget for this financial year was set at a conservative R1.5 million by 31 January R613k was spent and priorities are reviewed regularly. This budget has in the interim been increased to R1,660.000

Action Planning:

A Focus on greens

- \Rightarrow A gradual increase on the ratio of Bentgrass to Poa Annua on the greens.
- ⇒ Selective greens have had samples taken, and we are waiting on results; this includes general analysis, nematodes & pathogens.

Tees, surrounds & fairways

Thatch reduction & management remains the greatest issue facing these areas, with no easy solution.



The graph below shows moisture in green #1 over the period of 20 Jan – 18 Feb. The green band is an INDICATIVE ideal moisture level (it is important to note that for a raft of reasons this band can differ from course to course and even green to green). It is clear that the Max is well above and the min well below, but for the most part the average moisture levels are correct in that period.

In order to show what the "high" vs "low" means, please see image below; The "high" relates to those parts of the green that tend to retain water longer and the "low" to areas that react in the opposite fashion (a very small percentage of the green). We know from this visual to pay attention with hand watering to this central part of the green on that particular day.


